Census data is used to determine how many seats each state will have in the U.S. House of Representatives and in redistricting of state legislatures, county boards of supervisors and city councils.

On April 26, 2021, the Census Bureau delivered 2020 Census state population counts that will be used for apportionment. On August 16, 2021, the Census Bureau released redistricting counts to all 50 states. On September 20, 2021, the State of California released adjusted redistricting counts. These counts will be used to redraw legislative districts based on population changes. Pursuant to Elections Code Section 21500 et seq., "Following each federal decennial census, and using that census as a basis, the board shall adjust the boundaries of any or all of the supervisorial districts of the county so that the supervisorial districts shall be substantially equal in population as required by the United States Constitution." The Board must adopt an ordinance amending supervisorial districts no later than December 15, 2021.

On May 13, 2021, the Board approved the formation of the 2021 Advisory Redistricting Commission (Commission). On July 27, 2021, the Board appointed three (3) representatives for their respective districts for a total of a 15-member Commission. On August 31, 2021, the Board appointed alternates for the Commissioners in Districts 1, 2, 4 and 5. District 3 did not appoint an alternate. The Advisory Redistricting Commission meets on the first and third Thursday each month and has held a total of five (5) public meetings. Due to a resignation for District 3, as of August 25, 2021 the Board also appointed a Commissioner for District 3. The pool of applicants representing District 3 had been exhausted and there were no alternate options for an appointment to fill the vacancy.

#### **Communities of Interest**

The Advisory Redistricting Commission held five public hearings, one in each supervisorial district and all were held as hybrid meetings with access to the public both in-person or via Zoom. The public hearings were held on September 14, 2021 at Jesse G. Sanchez Elementary School in Salinas for District 1, on September 17, 2021 at Greenfield City Hall, City Council Chambers for District 3, on September 20, 2021 at the Andy Ausonio County Library Branch in Castroville for District 2, on September 27, 2021 at the Marina Library Branch in Marina for District 4 and on September 28, 2021 at the Monterey Peninsula Chamber of Commerce in Monterey for District 5. The public will also be able continue providing public testimony on the redistricting webpage, using the online tool: Survey123. The online tool also provides the public with the opportunity to draw and submit a district map as their recommendation.

Keeping Communities of Interests together is an important part of redistricting. Communities of Interest (COI) are overlapping sets of neighborhoods, networks, or groups that share interests, views, cultures, histories, languages, and values, and whose boundaries can be identified on a map. A Community of Interest can be defined in many ways. Relationships with political parties or elected officials and candidates are not considered communities of interest. And, while race and ethnicity can play a role in defining a COI, it cannot be used as a sole definition.

COIs are self-defined and create a common story. The following provides some examples of a Community of Interest:

- Shared interests in schools, housing, community safety, transit, health conditions, land use, and the physical environment, such as the coast, and farming and agricultural spaces;
- Common social and civic networks, including places of worship, homeowner associations, community centers, and shared use of community spaces like parks, dog parks, and shopping areas;
- Racial and ethnic compositions, cultural identities, and households that predominately speak a language other than English;
- Similar socio-economic status, including but not limited to income, home-ownership, and education;
- Shared political boundary lines from other jurisdictions, such as school districts, community college districts, and water districts;
- Residents who have been working together to advocate for a community issue, such as increasing after-school hours, getting assistance to come back from a natural disaster, or locating a health clinic in their neighborhood.

#### **Demographic Update**

On June 8, 2021, the Board approved a standard Professional Services Agreement with Lapkoff & Gobalet Demographic Research, Inc. (LGDR) to provide demographic consulting services to Monterey County and to the Monterey County Advisory Redistricting Commission. LGDR will present an overview of redistricting along with an objective demographic evaluation and analysis of current Supervisorial District boundaries using Census 2020 data.

With support from LGDR, the Advisory Redistricting Commission will begin the process to receive draft

map recommendations from the public and review proposed map drafts. A second series of public hearings, seeking public input will be launched in late October through early November.

A joint public hearing with the Board and Advisory Redistricting Commission will be held in mid-November to review the proposed draft map plan and the proposed ordinance. A subsequent joint public hearing will be held on December 7, 2021 for Board adoption of the final map plan by ordinance.
