SUMMARY/DISCUSSION:

The Resolutions to be adopted are necessary to establish that fees are in compliance with State and County requirements and to collect service charges on the County Tax roll. Each resolution contains a report of services charges for each individual County Service Area (CSA) within Exhibit A of corresponding resolution. Each report lists the parcel of land affected and the associated service charge to be assessed. Services provided are specified in each enabling ordinance. There are no changes in the amount being charged for service charges for any of the CSAs.
