# RECOMMENDATION:

It is recommended that the Board of Supervisors:

- a. Approve and authorize the Director of Health or Assistant Director of Health to execute a one-year MHS Agreement with Crestwood Behavioral Health, Inc. for the provision of mental health services for adults with severe psychiatric disabilities, for a maximum County obligation of \$1,348,840 retroactive to July 1, 2017 through June 30, 2018; and
- b. Approve and authorize the Director of Health or Assistant Director of Health to approve up to three (3) future amendments that do not exceed ten percent (10%) (\$134,884) of the original Agreement amount and do not significantly alter the scope of services.

# **SUMMARY/DISCUSSION**:

Crestwood Behavioral Health, Inc. has provided mental health services for approximately 13 years, and for 30 years prior under the previous corporate umbrella of Crestwood Hospitals. Crestwood has 18 California facilities ranging in size from 12 to nearly 200 beds, five of which are covered under the terms of this Contract. Crestwood's programs provide recovery oriented psychiatric services to adults, older adults, and transition-aged

youth with severe and persistent mental health illnesses. Crestwood provides intensive treatment programs with a high level of security and education to assist clients to live independently. Crestwood treatment services include an individualized program to meet the specific needs of each client, and a structured regimen with services to assist clients in their development of new skills.

The County currently maintains Agreement A-12686 with Crestwood Behavioral Health, Inc. which will expire on June 30, 2017. This new Agreement continues the past relationship with Crestwood Behavioral Health, Inc. providing for a continuum of existing services, serving current Monterey County clients. The Agreement drops three underutilized Crestwood facilities, but slightly increases the number of contracted beds at four remaining facilities based on projected demand. In addition, this Agreement adds a new Skilled Nursing Facility / Special Treatment Program at Crestwood Manor - Modesto, helping us to expand our treatment options for older adults.

The approval of this Agreement will provide the necessary resources and increase the options for clients to be placed in a facility that best suits their needs and to live in the least restrictive community setting as possible. This Agreement meets the requirements of the State Welfare and Institutions Code 5600 (Bronzan-McCorquodale Act), the California Code of Regulations Titles 9 and 22, and sustains the continuity of care services to seriously mentally ill clients of Monterey County.

This Agreement is delayed in being brought before your Board due to a backlog of Contracts terming in FY 2016-17 that required renewal in the February-June 2017 timeframe.

This Agreement contains the County's standard 30-day "no cause" provision (Section IV, B) and an additional defunding provision (Section IV, D), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

This work supports the following Monterey County Health Department 2011-2015 strategic plan initiative: 3) Ensure access to culturally and linguistically appropriate, customer-friendly, quality health services. It also supports one of the ten essential public health services, specifically: 7) Link people to needed personal health services and assure the provisions of health care when otherwise unavailable.

#### OTHER AGENCY INVOLVEMENT:

County Counsel and Auditor-Controller have reviewed and approved this Agreement as to legal form and fiscal provisions, respectively.

# FINANCING:

This Agreement is 100% funded by 1991 Mental Health Realignment revenues. The funds for this Agreement (\$1,348,840) are included in the Health Department's Behavioral Health (HEA012, Unit 8410) Fiscal Year 2017-18 Adopted Budget.
