SUMMARY/DISCUSSION:

During the past six months the Health Department has conducted an organizational study of comparable Public Guardian Offices. The result of that study was the development of the proposed organizational structure (Exhibit A). The restructuring plan will maintain administrative oversight infrastructure as well as providing support to the Deputy Guardians and will ensure effective and efficient operations to fulfill state and local mandates as they pertain to the Public Guardian's Office.

OTHER AGENCY INVOLVEMENT:
