RECOMMENDATION:

It is recommended that the Board of Supervisors:

- b. Authorize the Director of the Department of Social & Employment Services, or his designee, to sign up to three (3) amendments to this agreement, where the total amendments do not exceed 10% of the original contract amount, and do not significantly change the scope of work.

SUMMARY/DISCUSSION:

The agreement will provide nutritious meals to seniors residing in the City of Salinas Monday through Friday. The contract was originally awarded through an RFP process in May 2010, and was recommended by the Area Agency on Aging Advisory Council. The Elderly Nutrition Program is funded through the Older Americans Act. The contract was delayed coming to the Board due to late confirmation of funding from the state.

County Counsel, the Auditor-Controller and Purchasing have reviewed and approved this agreement.
