SUMMARY/DISCUSSION:

The County currently has Agreement A-14019 with Door to Hope which will expire on June 30, 2021. Door to Hope will continue to provide Outpatient group and individual therapy for adults and Residential Services for women including case management and Recovery Services.

This Agreement contains the County's standard 30-day "no cause" and termination for "cause" provisions (Section 5) and a defunding provision (Section 6), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

FINANCING: This Agreement is funded by 48% Federal Substance Abuse Block Grant (SABG), 34% Drug Medi-Cal, and 18% AB109 funding. The funds for FY 2021-22 are included in the Health Department Behavioral Health (HEA012, Unit 8410) FY 2021-22 Requested Budget. The funds for Fiscal Year 2022-23 will be included in the Department's requested budget for that fiscal year. Approval of this action has no impact on the County General Fund.
