Approve and authorize the Director of the Health Department or Assistant Director of the Health Department, on behalf of Monterey County, to sign Renewal and Amendment No. 1 to the non-standard Agreement (A-14241) with the City of Salinas to extend the term of the Agreement through June 30<sup>th</sup>, 2020, retroactively from July 1, 2019, for the County to provide spay and neuter veterinary services to the City of Salinas.

**RECOMMENDATION:**

It is recommended that the Board of Supervisors:

Approve and authorize the Director of the Health Department or Assistant Director of the Health Department, on behalf of Monterey County, to sign Renewal and Amendment No. 1 to the non-standard Agreement (A-14241) with the City of Salinas to extend the term of the Agreement through June 30<sup>th</sup>, 2020, retroactively from July 1, 2019, for the County to provide spay and neuter veterinary services to the City of Salinas.

**SUMMARY/DISCUSSION:**

On or about September 2015 a Memorandum of Understanding (MOU) between the County and the City of Salinas was executed to conduct an analysis and evaluation of Salinas Animal Services and Monterey County Animal Services to identify options for combining services and/or programs between the County and the City. This was intended as a first step towards further consolidation of City and County animal services for mutually beneficial purposes, with the possibility of a Joint Powers Authority being created to efficiently serve the residents of the City and unincorporated County. On November 7, 2017, County and City entered into a Memorandum of Agreement (MOA) for an Animal Control Services Administration Pilot Project. On May 14, 2018, County hired the Animal Services Administrator to implement the provisions of the MOA for Consolidated Services. On April 2, 2019, County and City entered into Amendment No. 1 to the MOA to amend the Scope of Services as set forth in Amendment No. 1 to the MOA.

Related to these consolidation efforts, the Board of Supervisors approved on February 26, 2019 a non-standard Agreement (A-14241) for the County to provide spay and neuter veterinary services to the City. The approved term of the Agreement was from execution to June 30, 2019. Amendment No. 1 to the non-Standard Agreement (A-14241) was

presented to the County after the June 30, 2019 term end date. The proposed Renewal and Amendment No. 1 will extend the term of the Agreement retroactively from July 1, 2019 through June 30, 2020 for the County to continue to provide spay and neuter veterinary services to the City of Salinas.

This activity supports the Monterey County Health Department 2018-2022 Strategic Plan Initiative: 2. Enhance community health and safety through prevention. It also supports one of the ten essential public health services, specifically: 6. Enforce laws and regulations that protect health and ensure safety.

OTHER AGENCY INVOLVEMENT:

The Office of County Counsel-Risk Management has reviewed and approved this Amendment No. 1 as to form and legality. The Auditor-Controller's Office has reviewed this Amendment No. 1 as to fiscal provisions.

FINANCING:

There is no impact to the General Fund resulting from the Board action. The estimated revenue to be generated for the County from this Agreement is approximately \$30,000.
