SUMMARY/DISCUSSION:

On January 10, 2023, the Human Resources Department was assigned Board Referral 2023.01 which purpose was to allow each supervisorial office greater opportunity to tailor its staffing to meet the needs of its district's constituents. In February 2023, the Human Resources Department provided preliminary responses to Board Referral No. 2023.01 which included labor market findings of how the County's current and prior comparable agencies staff their Board offices and provided options for the Board to consider. The Human Resource Department was directed to work with the County Administrative Office and the Office of County Counsel to provide a draft amendment to the Personnel Policies Practices Resolution Section A.38 Board of Supervisors Staff Assistants which could provide the Board with staffing flexibility while having no budgetary impact to their Board Office.

On March 21, 2023, the Human Resources Department returned and presented draft recommendations to the Section A.38 Board of Supervisors Staff Assistants. Per the direction provided at this meeting the Human
