It is recommended that the Board of Supervisors:

a. Approve a non-standard, retroactive agreement and authorize the County Administrative Officer, or designee, to sign an Agreement with Bottling Group, LLC accepting PepsiCo as Official Soft Drink and Bottled Water partner at WeatherTech Raceway Laguna Seca effective January 1, 2021 through December 31, 2025; and b. Approve and authorize the County Administrative Officer, or designee, to execute up to two (2) future amendments to this Agreement where the total amendments do not exceed 10% of the remaining agreement amount and do not significantly change the scope of work.

SUMMARY/DISCUSSION:

Pepsi has been the Official Partner with WeatherTech Raceway Laguna Seca (WRLS) since 2010. For the designation as Official Soft Drink and Bottled Water partner at WRLS, Bottling Group, LLC agrees to provide annual support funds in the amount of \$10,000 per year for the five (5) years of the Agreement and will receive sponsor benefits as outlined on Exhibit B of the Agreement.
