



Procedures for General Liability and Workers' Compensation Claims". The report summarized review of prior Third-Party Administrator (TPA) contracts for both General Liability and Worker's Compensation, and included recommendations regarding TPA contract compliance and improving the Risk Management function. The Auditor-Controller also provided additional recommendations regarding reorganization of the Risk Management function within the County. After hearing the report, your Board requested that the CAO report back with recommendations regarding the compliance review and Auditor's recommendations. This staff report provides recommended actions in response to Mr. Morgan's compliance review, as well as several options should your Board consider re-organization of the Risk Management function. Finally, staff recommends directing staff to prepare and recommend ordinance amendments to implement your Board's recommended organizational structure and/or the recommended improvements to the Risk Management Code provisions. Additional background information and discussion of the subject matter is provided in Exhibit A.

OTHER AGENCY INVOLVEMENT:

Pursuant to Section 2.12.040 of the County Code, the CAO is charged with recommending organizational restructuring. In addition, the CAO considered the Auditor's December 13<sup>th</sup> staff report, and consulted with the HR Director and County Counsel in preparation of this report.
