The Monterey County Sheriff's Office has the opportunity to obtain direct grant funds under the Expanding Access to Medication for Addiction Treatment (MAT) in County Criminal Justice Setting for the State Opioid Response. These funds are intended to assist in implementing specific and approved strategies to expand access to MAT of opioid addiction, screening and assessments in County Jails. This Sheriff's Office is a supportive partner in trying to provide incarcerated inmates with services they need within the County Jail.
