SUMMARY/DISCUSSION:

The Central California Alliance for Health (CCAH) is the Medi-Cal Managed Care Commission for Santa Cruz -Monterey-Merced counties. NMC provides outpatient laboratory, inpatient and outpatient services to CCAH members.

The County of Monterey, on behalf of NMC, entered into a Primary Hospital Services Agreement with CCAH with an original term of July 1, 2007 through December 31, 2007. Since then, the Agreement has been renewed automatically for successive one-year terms, subject to three termination provisions (immediate termination, termination without cause, termination with cause).

Healthcare Effectiveness Data and Information Set (HEDIS) Laboratory Test Results are a set of standardized performance measures maintained by the National Committee for Quality Assurance. HEDIS is a tool used by the majority of America's health plans to measure performance on important dimensions of care and service. CCAH offers incentive payments to contracted providers for the reporting of certain laboratory test results on a quarterly basis. The Eighteenth Amendment incorporates and continues the Outpatient Laboratory Incentive payment for the laboratory test results.

OTHER AGENCY INVOLVEMENT:

County Counsel has reviewed and approved this Amendment as to legal form and risk provisions. The Amendment has also been reviewed and approved by NMC's Finance Committee on 01/22/15 and by the NMC Board of Trustees on 02/06/15.

FINANCING:

There is a revenue opportunity of approximately \$5,000 from this incentive program.
