SUMMARY/DISCUSSION:

On June 25, 2013, the Board of Supervisors approved Renewal & Amendment #1 (Attachment B) to the contract with Great West Life & Annuity Insurance Corporation (GW) for recordkeeping and communication services for the Deferred Compensation 457(b) Plan as specified in the contract (Attachment A) extending the term of the contract to March 31, 2018. Amendment #2 has been prepared to augment and expand the services currently provided by GW including:

- 1) Acceptance of online Plan enrollment;
- 2) Acceptance, maintenance and filing of online, web-initiated beneficiary designations;
- 3) Acceptance, administration and disbursement of distribution requests, including those related to Qualified Domestic Relations Orders (QDROs), unforeseeable emergency as defined in United States Treasury Regulations, and severance of employment for reasons other than death or disability; and,
- 4) Acceptance and processing of requests for loans available under the Plan, including disbursement of loan proceeds.
