SUMMARY:

The Unit U physicians have organized with the Union of American Physicians and Dentists (UAPD). UAPD has requested that the County of Monterey modify the current approved standard Unit U physician employment agreement template for physicians at the Health Department to allow for authorization of changes as a result of the outcome of upcoming negotiations. The language requested is as follows:

"The Union of American Physicians and Dentists (UAPD) has recently organized to represent some physicians working at the Health Department. While the parties have not yet agreed on a Memorandum of Understanding ("MOU", also known as a Collective Bargaining Agreement), in the event that a provision of the forthcoming MOU explicitly contradicts this Agreement, this contract may be amended to ensure compliance with the MOU."

In order to remain competitive and continue to recruit and retain highly qualified physicians, the Health Department must be able to continue to process employment agreements for newly hired physicians and physicians renewing their agreement for another 1-year term.
