SUMMARY:

Renewal and Addendum Number 3 of Agreement with Honeywell International, Inc., provides for the implementation of additional Energy Efficiency Measures (EEM) described generally as Mechanical Systems Controls Marina Coastal Office. Renewal and Addendum Number 3 increases the Agreement by \$79,192, for a total amount not to exceed \$1,120,469; provides for a ten-percent contingency of \$7,919; and extends the term to September 30, 2013.

OTHER AGENCY INVOLVEMENT:

As the granting agency, the DOE is actively involved in project development. The Office of the County Counsel, and Auditor-Controller, have reviewed and approved Renewal and Addendum Number 3 of Agreement with Honeywell as to form and legality, and fiscal terms, respectively. The proposed board actions were presented to the Capital Improvement Committee for their support on June 3, 2013.

FINANCING:

The Renewal and Addendum Number 3 will renew and amend the Agreement in the amount of \$79,192, for a total amount not to exceed \$1,120,469, and provide a ten-percent (10%) contingency for unforeseen change orders, in the amount of \$7,919. The balance in Energy Efficiency and Conservation Block Grant Program (EECBG) funding, in the amount of \$71,991.06, as well as energy rebate revenue, in the amount of \$45,318, will be applied towards the implementation of additional Energy Efficiency Measures allowing for the project to be fully funded with EECBG funds and energy rebate funds. The estimated operations and maintenance cost of \$2,000 per year will be funded with the RMA-Public Works Facilities' annual operating budget.
