SUMMARY/DISCUSSION:

On July 12, 2005, the Board of Supervisors awarded a contract to Graniterock Company dba Pavex Construction Division for construction of the San Miguel Canyon Road/Hall Road Intersection Improvements, Project No. 05-152065. The project consisted of roadway improvements by widening existing roadways, installation of traffic signal, and a five-year Plant Establishment period. The contract is now complete in all respects in accordance with the Plans and Special Provisions. The work is ready to be accepted by the Board of Supervisors.

FINANCING:

There is no impact to the General Fund. The total project cost, including engineering, environmental, and construction, is \$1,949,471. The project was financed with Regional Surface Transportation Program funds and Traffic Impact fees.
