SUMMARY/DISCUSSION:

California Department of Social Services All County Letter No. 14-102 establishes new program rules and requirements for In-Home Supportive Services (IHSS) Provider enrollment and orientation. The new rules and requirements comply with Senate Bill (SB) 878. Under this Agreement the Monterey County Department of Social Services and SEIU-ULTCW agree to use the Registration Enrollment Video Appointment (REVA) webbased application for a portion of IHSS Provider enrollment, and concluding the orientation process by conducting a group orientation meeting allowing SEIU-ULTCW up to thirty (30) minutes to speak to providers.

OTHER AGENCY INVOLVEMENT:

County Counsel has reviewed and approved this Agreement.

FINANCING:

This is a zero-cost agreement required by the State of California between Monterey County and SEIU-ULTCW. Approval of this action will not have any impact to the County General Fund.
