## **SUMMARY / DISCUSSION:**

On July 23, 2021, MCPA Unit M&N ratified a Tentative Agreement (TA) with the County of Monterey. The TA was considered and approved by the Board of Supervisors on July 27, 2021 in closed session. The full MOU is presented for formal approval action today.

The MCPA Unit M&N MOU provides for changes to wages, benefits, and holidays as presented.
