RECOMMENDATION:

It is recommended that the Board of Supervisors:

a. Approve and authorize the Director of the Department of Social Services to sign an agreement for \$103,372 with VNA Community Services, Inc. for the provision of a Public Health Nurse at the CHERISH Receiving Center for the period July 1, 2015 through June 30, 2016; and
b. Authorize the Director of the Department of Social Services, or his designee, to sign up to (3) amendments to this agreement where the total amendments do not exceed 10% of the original contract amount, and do not significantly change the scope of work.

SUMMARY/DISCUSSION:

Through this Agreement, the Department of Social Services continues its support of children subjected to abuse and neglect, and the trauma experienced through removal from their homes, by providing a Public Health Nurse at the Cherish Receiving Center. Nursing support consists of completing medical assessments of youth who have been removed and temporarily placed at the 23-hour Cherish Receiving Center. Activities include screening and assessment of the health needs of children who are taken into protective custody and awaiting placement in a foster home.

OTHER AGENCY INVOLVEMENT:

The Auditor-Controller and Purchasing have reviewed and approved this agreement. County Counsel has approved the agreement as to form.

FINANCING:

Funding is provided by Realignment revenues. Sufficient appropriations and estimated revenues in SOC005 are included in the FY 2015-16 Adopted Budget. Approval of this action has no impact on the County General Fund.
