SUMMARY/DISCUSSION:

Full Stream Marketing & Design is a local advertising, marketing, and design agency located in Salinas, California. NMC has engaged the agency in the development of communication materials, multimedia, and advertisements and provision of media services with the goal of broadening awareness about NMC. NMC is currently engaged in a Request for Proposal (RFP) process reviewing proposals submitted by vendors for Marketing & Graphic Design Services. In order to avoid any interruption of services, NMC wishes to renew this Agreement until the final vendors are selected and new agreements are negotiated.

County Counsel has reviewed and approved this Amendment No. 7 as to legal form and risk provisions. Auditor-Controller has reviewed and approved this Amendment No. 7 as to fiscal provisions. The Amendment
