**RECOMMENDATION:**

It is recommended that the Board of Supervisors:

Consider receiving the Sheriff's response to the 2015 - 2016 Monterey County Civil Grand Jury Interim Final Report: "Body Worn Cameras".

**SUMMARY:**

The 2015 - 2016 Monterey County Civil Grand Jury Interim Final Report: "Body Worn Cameras" was issued on June 13, 2016. By law, the Board of Supervisors and elected County officials are required to respond to specific findings and recommendations as directed therein. Within 90 days of report issuance, on or before September 23, 2016, the Board's response must be filed with the Presiding Judge of the Superior Court, County of Monterey.

The County Administrative Office coordinated preparation of the recommended response to the 2015 - 2016 Monterey County Civil Grand Jury Final Report: "Body Worn Cameras" on behalf of the Board of Supervisors. The Board of Supervisors approved response should be deemed by the Monterey County Civil Grand Jury and the Presiding Judge of the Superior Court, County of Monterey, as the response of the Board of Supervisors to those issues raised by the Grand Jury regarding County operations, except as applicable to elected County officials.

The recommended response from the Sheriff's Office was submitted to the Board of Supervisors to accept his response to this report that was submitted to the Presiding Judge Hood within the dictated time allowed.

**OTHER AGENCY INVOLVEMENT:**

The County Administrative Office coordinated preparation of the recommended response to the 2015 - 2016 Monterey County Civil Grand Jury Final Report: "Body Worn Cameras" by the Sheriff's Office for the response from the Board of Supervisors.
