It is recommended that the Board of Supervisors:

SUMMARY/DISCUSSION:

This amendment adds Monterey County allocated Housing and Disability Advocacy Program (HDAP) funds that must be spent by June 30, 2025 to the existing contract with Central Coast Center for Independent Living (CCCIL) for HDAP services. The program provides housing search, housing placement support, and rental subsidies for participants. The target population is adults, youth, and families who are experiencing homelessness or are at risk of homelessness, may be disabled, are not receiving Social Security benefits or Cash Assistance Program for Immigrants (CAPI) benefits and wish to file or have already filed for them.

OTHER AGENCY INVOLVEMENT:

The Office of County Counsel has reviewed and approved the Agreements as to form, as has the Auditor-Controller's Office as to financial provisions.

FINANCING:

This is state allocated funding that is provided by the California Department of Social Services for the HDAP which is set to sunset June 30, 2025 and has no additional County General Fund contributions required. Sufficient appropriations and estimated revenues in Social Services Fund 001-5010-SOC005 are included in the FY 2024-25 Adopted Budget.

BOARD OF SUPERVISORS STRATEGIC INITIATIVES:

This Agreement correlates to the Health & Human Services Strategic Initiative adopted by the Board of Supervisors by working toward the goals of improving health and quality of life outcomes by providing housing search, placement support, and rental subsidies for HDAP participants.
