RECOMMENDATION:

It is recommended that the Board of Supervisors:
Approve the 2013-14 Secured Roll Tax Rates

SUMMARY/DISCUSSION:

Government Code Section 29100 requires secured roll tax rates to be approved by the Board of Supervisors each year. Since the passage of Proposition 13, the only rates that are subject to this procedure are those needed to provide taxes for the payment of principal and interest on certain long-term agency indebtedness. We are requesting that the Board of Supervisors approve the attached list of rates as those to be used for the 2013-14 secured roll.
