Title: PLN220086 CENTRAL COAST RENEWABLES LLC (FORMERLY N MTY CO UNIFIED SCHOOL DIST)
Public hearing to consider:

- Adoption of a resolution amending the North County Land Use Plan Figure 2 - Moss Landing Community Plan to change the land use designation on property located at 8142 Moss Landing Road (Assessor's Parcel Number 133-212-008-000) from "Public/Quasi-Public: Educational - Scientific" to "General Commercial", and amend the text of the Moss Landing Community Plan to delete text referencing the school district office building on Moss Landing Road;
- Adoption of an ordinance to amend Sectional District Map 20-03 of Section 20.08.060 of the Monterey County Code to change the zoning designation on the property from "Public-Quasi Public (Coastal Zone) [PQP (CZ)]" to "Moss Landing Commercial (Coastal Zone) [MLC (CZ)]"; and
- A Coastal Administrative Permit to allow a change of use within an existing structure from North Monterey County unified school district offices to an office and shop for an electrical solar contractor.

Project Location: 8142 Moss Landing Road, Moss Landing Community Plan
Proposed California Environmental Quality Act (CEQA) Action: Exempt pursuant to CEQA Guidelines sections 15303 (existing building) and 15265 (coastal), and none of the exceptions from section 15300.2 apply.
