RECOMMENDATION:

SUMMARY/DISCUSSION:

This agreement provides legal support services to Monterey County seniors, including legal assistance, family caregiver legal assistance and elder abuse prevention services. This contract was originally awarded through an RFP process in May 2010, and recommended by the Area Agency on Aging Advisory Council. The program is funded by the Federal Older Americans Act.
