SUMMARY/DISCUSSION:

Through this Agreement, the Department of Social Services continues its support of children subjected to abuse and neglect, and the trauma experienced through removal from their homes, by providing a Public Health Nurse at the Cherish Receiving Center. Nursing support consists of completing medical assessments of youth who have been removed and temporarily placed at the

23-hour Cherish Receiving Center. Activities include screening and assessment of the health needs of children who are taken into protective custody and awaiting placement in a foster home.
