RECOMMENDATION:

It is recommended that the Board of Supervisors:

SUMMARY/DISCUSSION:

Family-to-Family is a community effort to establish a network of family-focused foster care that is neighborbased, culturally sensitive, and located primarily in the communities in which the children live. Community Human Services works to support the caregivers and to provide services focused on retention efforts to ensure children stay in Monterey County.

This agreement with Community Human Services provides the Department of Social Services, Family and Children's services, with assistance in supporting ongoing efforts to Family-to-Family throughout Monterey County.

OTHER AGENCY INVOLVEMENT:

The Auditor-Controller and Purchasing have reviewed and approved this agreement. County Counsel has approved the agreement as to form.

FINANCING:

This agreement is funded by Realignment revenues. Sufficient appropriations and estimated revenues for SOC005 are included in the FY 2015-16 Adopted Budget. Approval of this action has no impact on the County General Fund.
