SUMMARY:

See Attachment A - Summary of Agreement. The original Agreement No. A-11132 allowed for purchase, configuration and operation of the Accela Automation permit tracking system through calendar year 2012. Amendments since that time covered extending the term, adding annual maintenance costs for the extended term, and purchase of additional licenses for the software product.

DISCUSSION:

Amendment No. 4 allows Accela, Inc. to provide report training to County staff on the Accela Automation software product. Amendment No. 4 will increase this Agreement by \$4,560, for a total amount not to exceed \$2,445,051.
