#### SUMMARY/DISCUSSION:

Key schedule components and budget status are summarized below.

Budget and Schedule: The overall Project is on budget and schedule.

<u>Design</u>: Wald Ruhnke Dost, Architects; design is complete.

<u>Milestones</u>: The next milestones include; Bid opening February 2, 2017; Board of Supervisors award of construction contract March 21, 2017; start of construction May, 2017.

<u>Selective Demolition:</u> Selective abatement and building interior and courtyard landscaping demolition is complete. Fencing to the courtyard was retained for the tenant improvement phase.

Window and Door Replacement: Window replacement is complete.

<u>CEQA and SEIR</u>: The CEQA and SEIR process is complete.

<u>Project Bidding:</u> The Board of Supervisors authorized advertising for construction bids on December 13, 2016. The first addendum to the construction documents was released on December 28, 2016.

#### OTHER AGENCY INVOLVEMENT:

RMA-Public Works coordinated with the County Administrative Office and all selected agency tenants who

will reside in the East-West Wing Building to develop the Project Plans and Specifications.

## FINANCING:

The project is financed by Certificates of Participation (COPs) in the amount of \$52,000,000 issued for the specific purpose of completing both the Schilling Place and East/West Wing renovation projects. Specifically, the East/West Renovation Project is funded by a COP allocation of \$36,000,000 and County funds in the amount of \$624,623 for a pre-bid total project cost of \$36,624,623. Total expenditures through the end of this quarter are \$7,748,799. Funding for this project is contained in Fund 404 - Facilities Master Plan Projects.
