The 2016 - 2017 Monterey County Civil Grand Jury Interim Final Report: "Jail Insufficient Number of Deputies: Car 54 Where are You" was issued on June 7, 2017. Within 90 days of report issuance, on or before September 7, 2017, the Board's response must be filed with the Presiding Judge of the Superior Court, County of Monterey.
