Approve the Bingo License Application for San Antonio Community Betterment Association (SACBA) pursuant to Chapter 7.08 of the Monterey County Code effective January 23, 2018 through January 22, 2019. RECOMMENDATION:

It is recommended that the Board of Supervisors approve the Bingo License Application for San Antonio Betterment Association pursuant to Chapter 7.08 of the Monterey County Code effective January 23, 2018 through January 22, 2019.

#### **SUMMARY:**

On November 20, 2017, the San Antonio Community Betterment Association (SACBA) submitted a Bingo License application to the Clerk of the Board with the requisite \$50.00 application fee. The Clerk of the Board transmitted a copy of the application to the Monterey County Sheriff's Office on November 20, 2017 for a tenday review, pursuant to Chapter 7.08 of the Monterey County Code.

Pursuant to Chapter 7.08 of the Monterey County Code, the Board of Supervisors is the responsible body for the issuance of Bingo Licenses. Upon approval by the Board of Supervisors, the Clerk of the Board will issue the applicant the Bingo License effective January 23, 2018 through January 22, 2019, a draft of which is attached to this board report.

The Sheriff's office has reviewed and provided a written response to the Clerk of the Board with no objections to the issuance of the bingo license. Receiving no objection from the Sheriff's Office, the Clerk of the Board has prepared and assembled this board report for approval with the aforementioned materials.
