#### **SUMMARY**

It is requested that the Board of Supervisors approve a resolution to facilitate completion of lease paperwork with Motorola Solutions for the leasing of forty (40) radios for the Monterey County Adult Correction Facility.

#### **DISCUSSION:**

Your Board approved a lease agreement between the County of Monterey and Motorola Solutions, on behalf of the Monterey County Sheriff's Office, on the November 14, 2017 meeting.

Subsequent to that action, it was discovered that the Resolution enabling the lease was not properly entered into the Legistar system, and for that reason, was not submitted for action to the Board of Supervisors. The Resolution was included in the lease documents (as Exhibit E) submitted to the Board on that date. This report and the attached Resolution, are being presented to rectify that oversight, and to obtain approval of the Resolution.

#### **FINANCING**

The first payment due under this Lease is due in Fiscal Year 2018-19, in the amount of \$28,203.87. This payment, and the four subsequent annual payments of \$28,203.87 (\$141,019.35 total) will be incorporated as part of the subsequent years' budget development process. No General Fund Contribution increase for FY 2017-18 will result from approval of this lease agreement.
