### **RECOMMENDATION:**

It is recommended that the Board of Supervisors:

### **SUMMARY:**

The Health Department seeks authorization to execute an Agreement with the Department of General Services/Office of Administrative Hearings for a period of five years from the date of approval and execution by all parties.

### **DISCUSSION:**

The Medical Director of the Monterey County Emergency Medical Services (EMS) Agency is the local authority for certifying Emergency Medical Technicians (EMT) in the State of California pursuant to Health and Safety Code, Division 2.5, Section 1797.210 (a). In addition, California Code of Regulations, Title 22, Chapter 6, Section 100209 states that the Medical Director may, "upon determination of disciplinary cause, take certification action against an EMT or Advanced EMT to deny, suspend, or revoke, or place a certificate holder on probation." To ensure due process, California Government Code, Title 2, Division 3, Part 1, Section 11502 (a) requires the local EMS Agency to use an Administrative Law Judge in cases where an Emergency Medical Technician's (EMT) certification is suspended or revoked or if an EMT applicant is denied certification and the applicant appeals the decision of the EMS Medical Director.
