### RECOMMENDATION:

b. Approve and authorize the Monterey County Contracts/Purchasing Officer to approve modifications to the purchase order where modifications do not significantly alter the scope of the Agreement and do not exceed 10% of the current aggregate five-year total (\$18,873).

### SUMMARY/DISCUSSION:

This request will support the relocation plan of the County's existing Mail Operations program from its current location at 855 East Laurel Drive, Building C, to 1488 Schilling Place. The planned relocation is scheduled to begin on June 1, 2019, with a completion date of July 1, 2019. In preparation for the move it has been identified by the current provider of the existing Postage Meter Units that the existing units located at 855 East Laurel Drive are over five (5) years old and need to be replaced in order to comply with new United States Postal Service (USPS) requirements. The relocation plan provides the County with the opportunity to complete the

necessary replacement with little or no-disruption in mail services. The existing units will remain operational until the new units have been fully installed and tested with a go-live date of July 1, 2019.

**OTHER AGENCY INVOLVEMENT:**

County Counsel has reviewed and approved this request, as has the Auditor-Controller's Office.

**FINANCING:**

Cost associated with the new agreement with MailFinance Inc. are to be incurred over the next five fiscal years; July 1, 2019 through June 30, 2024. The lease will cost \$37,743 annually for five years, totaling \$188,714. The County's mail services are reimbursed on a full-cost-recovery basis from those departments using the service. The FY 2019-20 recommended budget will include appropriations to cover the increased annual costs.
