### RECOMMENDATION:

It is recommended that the Board of Supervisors:

Approve and authorize the Director of Health or Assistant Director of Health to execute an Amendment No. 2 to Agreement A-13138 with Central Coast Center for Independent Living (CCCIL) to extend the Rapid Rehousing Access provisions of the Whole Person Care Program 2 an additional 18 months, while also extending CCCIL Program 1 counseling and outreach services an additional two fiscal years, increasing the contract amount payable by County to Contractor by a total of \$1,003,606 for Fiscal Year (FY) 2018-19 through FY 2020-21, for a new maximum County obligation of \$1,612,915, for a revised term of July 1, 2016 through June 30, 2021.

### SUMMARY/DISCUSSION:

Central Coast Center for Independent Living in Salinas, CA is one of a nationwide network of Centers for Independent Living whose philosophy is that people with disabilities should have the same civil rights, options and control over choices in their own lives as do people without disabilities.

With the approval of Amendment No. 2, CCCIL will continue to provide work incentive counseling and

independent living skills services to mental health clients, including youth, and their family members in an effort to determine their potential eligibility for various work incentive programs, extending those services through FY 2020-21. This Amendment No. 2 also expands and extends Whole Person Care (WPC) Rapid Re-housing and Support Services, and Rapid Re-housing Access through December 31, 2020, providing case management services to clients who are homeless or chronically homeless.

This Agreement contains the County's standard 30-day "no cause" provision (Section IV, B) and an additional defunding provision (Section IV, D), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

This work supports the following Monterey County Health Department 2018-2022 strategic plan initiative: 3) Ensure access to culturally and linguistically appropriate, customer-friendly, quality health services. It also supports one of the ten essential public health services, specifically: 7) Link people to needed personal health services and assure the provisions of health care when otherwise unavailable.

OTHER AGENCY INVOLVEMENT:

County Counsel-Risk Management and Auditor-Controller have reviewed and approved this Amendment No. 2 to A-13138 as to legal form and fiscal provisions, respectively.

FINANCING:

This Agreement is funded by Mental Health Services Act Community Services and Supports (MHSA CSS), and Whole Person Care (WPC) Grant revenues. The funds for this Agreement (\$500,063) are included in the Health Department's Behavioral Health (HEA012, Unit 8410) Fiscal Year 2018-19 Adopted Budget. The funds for this Agreement for FY 2019-20 (\$500,063) and FY 2020-21 (\$316,583) will be included in the Health Department's Behavioral Health (HEA012, Unit 8410) Fiscal Year 2019-20 and Fiscal Year 2020-21 Requested Budgets.
