#### SUMMARY:

The Office of Emergency Services (OES) is seeking authorization to execute an Agreement Amendment #2 between the City and County of San Francisco and the County of Monterey as a necessary step in order for the County to participate in the Department of Homeland Security ("DHS") FY 2018 Urban Area Security Initiative (UASI) Grant Program within the Bay Area UASI Region. The department is also seeking authorization to enter into an MOU with the Bay Area UASI for a shared Training Program. In addition, OES is requesting authorization for the Auditor Controller to increase estimated revenue and appropriation in the amount of \$370,945 due to unanticipated revenue and expenditures.

### DISCUSSION:

The Bay Area Urban Area Security Initiative (UASI) is funding a Training and Exercise Program in the amount of \$370,945 for the Tri-Counties of the UASI South Hub (Monterey County, Santa Cruz County and San Benito County).
