### SUMMARY:

On May 29, 2019, staff facilitated the fifth Planning Commission (PC) Workshop for the MLCP Update to discuss the topic of Land Use. On May 30<sup>th</sup>, 2019, a notice was distributed for a sixth PC workshop on June 12, 2019. That workshop would continue the discussion on Land Use Policies.
