<u>RECOMMENDATION</u>:

It is recommended that the Board of Supervisors:

Approve and authorize the Director of Health or Assistant Director of Health to execute Amendment No. 1 to Mental Health Services Agreement A-13855 with JDT Consultants, Inc. to increase Fiscal Year (FY) 2018-19 amount from \$855,614 to \$1,280,614 (an increase of \$425,000) for a revised total Agreement amount not to exceed \$2,991,842 for the term July 1, 2018 through June 30, 2021.

SUMMARY/DISCUSSION:

JDT Consultants, Inc. provides Therapeutic Behavioral Services (TBS) to Monterey County Medi-Cal eligible children who meet criteria for medical necessity and Home Alternatives to Residential Treatment (HART) to Monterey County children who are receiving Special Education services through their Individual Education Plan (IEP) and have been identified by their IEP teams as being at imminent risk of residential treatment. TBS is an intensive one-to-one, face-to-face, short term outpatient treatment intervention for beneficiaries under age 21 with serious emotional disturbances who are experiencing stressful transition or life crisis and may be at risk of psychiatric hospitalization. HART services provide highly individualized, intensive case management and one-to-one behavioral intervention to address the social emotional needs presenting barriers to academic success. This Amendment No. 1 increases the contract amount to provide for the estimated level of services needed to meet the program's needs.

This Agreement contains the County's standard 30-day "no cause" provision (Section IV, B) and an additional defunding provision (Section IV, D), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

This work supports the Monterey County Health Department 2018-2022 Strategic Plan initiative: 3. Ensure access to culturally and linguistically appropriate, customer-friendly, quality health services. It also supports the following of the ten essential public health services, specifically: 7. Link people to needed personal health services and assure the provisions of health care when otherwise unavailable.

OTHER AGENCY INVOLVEMENT:

County Counsel-Risk Management and Auditor-Controller have reviewed and approved this Amendment No. 1 to Agreement A-13855 as to legal form and fiscal provisions respectively.

FINANCING:

This Amendment is funded by Federal Financial Participation (31%), Early Periodic Screening, Diagnosis, and Treatment (17%), and Special Education Local Plan Area (51%). The funds for this Agreement (\$425,000) will be included in the Health Department's Behavioral Health (HEA012, Unit 8410) Fiscal Year 2018-19 Adopted Budget.
