SUMMARY/DISCUSSION:

These services will enable WeatherTech Raceway Laguna Seca to ensure a reliable source of garbage pick-up and services for events held within the WeatherTech Raceway Laguna Seca facility. The initial term of the Agreement will begin July 1, 2019 and terminate June 30, 2024. This request will authorize the Contracts/Purchasing Officer or Contracts/Purchasing Supervisor to sign additional Agreements for garbage pick-up and services with qualified contractors who meet the minimum requirements of the County of Monterey. Work contracted under these Agreements shall not exceed a total aggregate of \$625,000 for all Agreements issued under RFP #10712 in accordance with the terms and conditions set within each Agreement.

Services include, but are not limited to, trash removal/collection, recycling removal/collection, and setup and teardown receptacles, including supervision and labor to provide garbage pick-up and services as directed by staff in support of events held at the facility. The Agreement is based on the County requirements as set forth in the terms and conditions of RFP #10712. Copies of the Agreements are on file with the Clerk of the Board.

OTHER AGENCY INVOLVEMENT:

County Counsel has reviewed and approved the Agreement as has Auditor-Controller's Office.

FINANCING:

Funds for these services are contained within the approved budget allocations of the department utilizing the services. Expenditures will depend on the actual services requested by individual County departments.
