SUMMARY/DISCUSSION:

These services will enable Weathertech Raceway Laguna Seca to ensure a reliable source of sanitation units and fixed restroom cleaning service for events held within the Weathertech Raceway Laguna Seca facility. The initial term of the Agreements will begin July 1, 2019 and terminate June 30, 2024. This request will authorize the Contracts/Purchasing Officer or Contracts/Purchasing Supervisor to sign additional Agreements for sanitation unit rental and services with qualified contractors who meet the minimum requirements of the County of Monterey. Work contracted under this Agreement shall not exceed a total aggregate of \$750,000 for all Agreements issued under RFP #10704 in accordance with the terms and conditions set within each Agreement.

Services include, but are not limited to, the delivery, cleaning, maintenance, supervision, labor, material, and all equipment necessary to provide sanitation units and fixed restroom cleaning services as directed by staff in support of events held at the facility. The services of this Agreement are based on the County requirements as set forth in the terms and conditions of RFP #10704. Copies of the Agreements are on file with the Clerk of the Board.

OTHER AGENCY INVOLVEMENT:

County Counsel has reviewed and approved the Agreement as has Auditor-Controller's Office.

FINANCING:

Funds for these services are contained within the approved budget allocations of the department utilizing the services. Expenditures will depend on the actual services requested by individual County departments.
