Approve and authorize the Director of Health or Assistant Director of Health to execute Amendment No. 2 to Substance Use Disorder Treatment Services Agreement with Valley Health Associates for the provision of alcohol and drug recovery services in the amount of \$1,728,642 for Fiscal Year (FY) 2019-20, for a new total Agreement amount not to exceed \$3,457,281 for a revised term of July 1, 2018 through June 30, 2020.

## **<u>RECOMMENDATION</u>**:

It is recommended that the Board of Supervisors:

Approve and authorize the Director of Health or Assistant Director of Health to execute Amendment No. 2 to Substance Use Disorder Treatment Services Agreement with Valley Health Associates for the provision of alcohol and drug recovery services in the amount of \$1,728,642 for Fiscal Year (FY) 2019-20, for a new total Agreement amount not to exceed \$3,457,281 for a revised term of July 1, 2018 through June 30, 2020.

## SUMMARY/DISCUSSION:

The County currently has a one-year Agreement A-14021 for a current contracted dollar amount of \$1,728,639 with Valley Health Associates, which will expire on June 30, 2019. This Amendment extends the Agreement by one additional fiscal year to begin July 1, 2019 and term June 30, 2020. As part of the Monterey County Health Department, Behavioral Health Bureau's Drug Medi-Cal Organized Delivery System (DMC-ODS) Waiver Implementation Plan, Valley Health Associates will continue to provide the following services: Medication Assisted Treatment include methadone dosing, Outpatient group and individual therapy for youth and transition age youth including case management and Recovery Services.

This Agreement contains the County's standard 30-day "no cause" and termination for "cause" provisions (Section 5) and a defunding provision (Section 6), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

This supports the Monterey County Health Department 2018-2022 strategic plan initiative: 1. Ensure access to culturally and linguistically appropriate, customer-friendly, quality health services. It also supports one of the ten essential public health services,

specifically: 7. Link people to needed personal health services and assure the provision of health care when otherwise unavailable

#### OTHER AGENCY INVOLVEMENT:

County Counsel-Risk Management and Auditor-Controller have reviewed and approved as to legal form and fiscal provisions respectively.

FINANCING:

This Agreement is funded by 48% Federal Substance Abuse Block Grant (SABG), 34% Drug Medi-Cal, and 18% AB109 funding. The funds for FY 2019-20 are included in the Health Department's Behavioral Health Bureau (HEA012, Unit 8410) FY 2019-20 Requested Budget.
