It is recommended that the Board of Supervisors:

## SUMMARY/DISCUSSION:

This request supports the required services of the San Francisco Region Sports Car Club of America (SFRSCCA) in support of Motorsport events held at the WeatherTech Raceway Laguna Seca in accordance to approved SFRSCCA guidelines. SFRSCCA shall provide the PRO Support Services, such as, but not limited to

flagging and communication services required to provide a safe, effective and timely course control during race events conducted at the WRLS facility. The scope of work within the agreement shall be accomplished using certified course marshals in accordance to the terms and conditions of the agreement. The agreement shall be for one (1) year, the 2019 Race Season. SFRSCCA provided limited services during the Ferrari Challenge which were essential to participant and public safety, hence retroactive approval is requested.

### OTHER AGENCY INVOLVEMENT:

The Office of County Counsel has reviewed and approved this report.

#### FINANCING:

The cost of this agreement is not to exceed \$300,000 and funding for the agreement is included in the Laguna Seca Recreation Area Fiscal Year 2018-2019 under Appropriation Unit CAO029, Budget Unit 8441.
