### SUMMARY/DISCUSSION:

The Board of Supervisors recently appointed Leslie J. Girard as County Counsel, succeeding Charles J. McKee, who has been appointed County Administrative Officer. It is necessary and appropriate to authorize the execution of an employment agreement for Mr. Girard's services, pursuant to Government Code section 27640 et seq. The terms of the agreement have been negotiated by and are satisfactory to the County and Mr. Girard and are consistent with the County's published salary schedule for the position and the County's Personnel Policies and Practices Resolution.
