### SUMMARY/DISCUSSION:

VIASYN, Inc. has provided energy scheduling coordination and financial settlement services to the Monterey County Water Resources Agency (Agency) for the Nacimiento Hydroelectric Facility under the Agency's Power Purchase Agreement since July 1, 2013.

This Amendment No. 6 continues the services of VIASYN, Inc., and will extend the term of the contract through the Fiscal Year 2020-21.
