Adopt a Resolution approving the Fiscal Year 2020-21 Budget for the East Garrison Public Financing Authority.

### RECOMMENDATION:

It is recommended that the Board of Supervisors adopt a resolution approving the Fiscal Year 2020-21 Budget for the East Garrison Public Financing Authority.

### SUMMARY/DISCUSSION:

The County Administrative Office recommends that the Board of Supervisors approve and adopt the Fiscal Year (FY) 2020-21 Budget for the East Garrison Public Financing Authority. This budget is unchanged from the FY 2020-21 Recommended Budget as presented and received by the Board during Budget Hearings on June 1-2, 2020. The FY 2020-21 Budget for the East Garrison Public Financing Authority includes \$55,000 in total appropriations, offset by estimated revenue of \$59,000, for a total net increase of \$4,000 in unreserved fund balance.

### OTHER AGENCY INVOLVEMENT:

The County Administrative Office prepared the East Garrison Public Financing Authority FY 2020-21 Adopted Budget Resolution reflecting Board approval of the FY 2020-21 Recommended Budget as presented on June 1-2, 2020.

### FINANCING:

The East Garrison Public Financing Authority FY 2020-21 Adopted Budget Resolution reflecting Board approval by reference of the FY 2020-21 Recommended Budget as presented on June 1-2, 2020 represents a balanced budget and meets all requirements for adoption.
