## **<u>RECOMMENDATION</u>**:

It is recommended that the Board of Supervisors appoint Colleen Courtney to serve as Supervisor Mary Adams' second alternate on the Transportation Agency for Monterey County.

## SUMMARY/DISCUSSION:

At the beginning of each calendar year, the Chair of the Board of Supervisors proposes to the full Board the appointment of Board members and staff to serve on a variety of standing and ad hoc committees of the Board and also to a number of external boards, committees, commissions and other governmental entities which require representation of the County by a member of the Board of Supervisors. These appointments generally remain for the calendar year unless and until modified by subsequent action by the Board.

The appointments for calendar year 2021 were approved by the Board on January 12, 2021 and revised on February 2, 2021. Supervisor Adams has requested that a second alternate be appointed from her office to serve on the Transportation Agency for Monterey County (TAMC).

If approved, this change will go into effect immediately and the County Administrative Office will notify TAMC.

The County Administrative Office drafted this report with input from Supervisor Mary Adams' Office.
