- b. Approve and authorize the Contracts/Purchasing Officer or his designee to execute up to three (3) future amendments to this Agreement where the total amendments do not exceed 10% (\$5,000) of the agreement amount and do not significantly change the scope of work.

SUMMARY/DISCUSSION:

A&D Narigi Consulting, LLC requests retroactive approval of a 3-year agreement with Nestle Waters North America, Inc. This request supports the use of Nestle Waters North America Inc., for 5-gallon bottles of drinking water, rental water coolers, and specialty beverages, as requested, for both the daily needs of all offices at Laguna Seca Recreation Area (LSRA), as well as for event needs, as ordered. Bottled water is mandatory as there is no potable water at LSRA. Water bottles are replenished, as needed, based on consumption.
