SUMMARY/DISCUSSION:

This request supports the use of SmartWAVE Technologies, LLC for Electronic Flagging System (EFS) support during events at WeatherTech Raceway Laguna Seca. SmartWAVE Technologies shall provide electronic flagging functionality, basic troubleshooting, EFS network analysis, monitoring and related IT services to support track operations. This service is critical for the safe execution of our premier racing events.

The County received the Agreement already signed with a date that is now retroactive. The vendor has not
