SUMMARY/DISCUSSION:

Testforce USA, Inc. is a trusted authorized Master Distributor in the United States for Wireless, Avionics, and Mobile Radio Test Equipment. The County of Monterey currently utilizes Aeroflex digital radio test sets for which Testforce USA, Inc. provides software options to automate testing that is currently performed manually. The Testforce software ensures Monterey County Radio Technicians are able to quickly and accurately correct deviations from manufacture specifications to ensure the safety and reliability of public safety personnel.

The Office of County Counsel has reviewed this Agreement as to form and cannot approve due to the non-standard provisions.
