RECOMMENDATION:

It is recommended that the Board of Supervisors:

SUMMARY/DISCUSSION:

The Monterey County Health Department continues to provide services to individuals and communities in Monterey County affected by Human Immunodeficiency Virus (HIV). Access Support Network (ASN) serves the San Luis Obispo County and Monterey County communities, assisting individuals living with HIV and Hepatitis C virus (HCV) infections. ASN offers testing and prevention education opportunities for various groups throughout the community.

ASN offers non-medical support services to people living with HIV in service categories allowed under Health Resources and Services Administration (HRSA) Ryan White Part B funding guidelines including but not limited to: Housing Services, Case Management (non-medical), Medical Transportation, Health Insurance Premium and Cost Sharing Assistance, and Food Bank/Home Delivered Meals.

This work supports the Monterey County Health Department 2018-2022 Strategic Plan Initiatives: 1. Empower the community to improve health; 2. Enhance public health and safety through prevention; and 3. Ensure access to culturally and linguistically appropriate, customer-friendly, quality health services.

OTHER AGENCY INVOLVEMENT:

The office of County Counsel and the Auditor-Controller have reviewed and approved this Agreement as to form and fiscal provisions, respectively.

FINANCING:

This contract is funded 100% with State grant monies through the HIV Care program. There are sufficient appropriations in Health Department's Public Health Bureau (HEA003-8124) FY 2020-21 Adopted Budget and FY 2021-22, FY 2022-23, and FY 2023-24 Requested Budgets.
